SA8000: 2008 is based on the principles of **international human rights** norms as described in **International Labour Organisation conventions**, the **United Nations Convention on the Rights of the Child and the Universal Declaration of Human Rights**. It measures the performance of companies in eight key areas: child labour, forced labour, health and safety, freedom of association and collective bargaining, discrimination, disciplinary practices, working hours and compensation.
